Your primary assignments:

- Work for Greenland's access and benefit from additional funds made accessible for the Overseas Countries and Territories (OCT)
- Possibly collaborate with other OCT's under the auspices of OCTA Overseas Countries and Territories

- Monitor and disseminate information as well as write reports of various EU related topics of relevance to Greenland
- Assist in ad hoc tasks at the representation as well as with topics raised at the EU level relevant to Greenland
- When needed, participate on prepare visits from Greenland and from the EU to Greenland with the rest of the employees at the representation

- You have a sound knowledge about Greenlandic society and culture
- You have as much as possible proficient communication and dissemination skills in English, Greenlandic and Danish
